

#### CIVIL PROCEDURE & EVIDENCE

Butch, a resident of Bexar County, Texas, was working on a construction site in Comal County, Texas, when an asphalt truck operated by Sam, an employee of Cactus Construction Company ("Cactus"), backed over Butch, severely injuring him. Cactus is a Texas corporation, with its principal place of business in Harris County, Texas. Giant Corp. ("Giant"), a Delaware corporation, manufactured the back-up alarm on the asphalt truck. Giant has customers throughout the United States, including many in Texas, and is headquartered in Little Rock, Arkansas.

Butch files suit against Giant and Cactus in Bexar County, Texas.

Giant wants to challenge the Bexar County court's jurisdiction over it on the ground that it is not amenable to process issued by a Texas court.

When the case is called for trial, all of the witnesses who have been subpoenaed to testify are in the courtroom. Butch does not want the witnesses to be in the courtroom once testimony starts.
11. What must Butch do to exclude the witnesses from the courtroom, and what instructions, if any, must the Court give the witnesses?
Butch was arrested five years ago for driving while intoxicated. He wants to prevent the defendants from mentioning the arrest during jury selection.
12. How can Butch keep the defendants from discussing the arrest during jury selection, and what must he show?
During voir dire, one of the veniremen states that he used to work for Cactus and feels Cactus treated him unfairly. He also states he is not sure he can be fair to all parties if he is selected to serve as a juror.
13. What can Cactus do to try to keep this venireman from serving on the jury? Explain your answer.

During the trial, one of Cactus's witnesses testifies differently from what he said in his deposition.
14. What steps must Butch take before impeaching the witness with his previous testimony?
During the trial, Giant calls a witness to testify. Giant had not identified the witness any of its discovery responses. Butch objects.
15. What must Giant show the Court before the witness will be permitted to testify?
During his testimony, Butch states that immediately after the accident, the driver of the asphalt truck ran to his side and stated, "I'm so sorry. I wasn't looking where I was going Cactus objects to the testimony on the basis that it is hearsay.

16. How should the Court rule on Cactus's objection? Explain your answer.	
During trial, Giant moves to admit into evidence a certified copy of the report of a sheriff's deputy who inspected the asphalt truck immediately after the accident. The report states that the back-up alarm on the asphalt truck was not connected to the truck's battery. Cactus objects to the admission of the report on the basis that Giant has failed to properly authenticate it.	
17. How should the Court rule on Cactus's objection? Explain your answer.	
After Butch rests his case, Giant contends that the evidence is insufficient to support a verdict for Butch against Giant.	
18. How can Giant raise this issue with the Court, at this state of the proceedings?

During jury deliberations a disagreement arises among the jurors about the substance of a statement made by one of the witnesses who testified at trial.
19. What can be done to resolve the jurors' disagreement? Explain your answer.
The jury returns a verdict in favor of Butch against both defendants. Giant contends that the jury's verdict against it is not supported by the evidence.
20. How can Giant raise this matter with the Court, and when must Giant raise it?
